Changes to the 51+ Product Portfolio

CareFirst BlueCross BlueShield (CareFirst) continuously evaluates its product portfolio to ensure responsiveness to customer needs. As a result of our most recent evaluation, we are streamlining our 51+ product portfolio to eliminate certain options within product lines. Effective immediately, we are removing 46 plans per jurisdiction for **new sales**.

These following plans have been removed from upcoming new sales quotes. The broker portal and 51+ product portfolios are being updated to reflect that these plans are no longer available for new sales. Additionally, starting March 1, 2020, we will begin discontinuing these plans upon renewal. In total, these changes will only impact **224** renewal groups.

Frequently Asked Questions

Why are certain plan options no longer available for new sales?

We are removing less popular plans, simplifying plan differences and standardizing plan benefits to create space for future product development.

How will we handle renewals for these plans?

Starting with renewing groups March 1, 2020, groups will be mapped to the most comparable plan (in terms of network, benefits and base rate). Other options will also be available within the updated product portfolio.

When and how are impacted accounts being notified?

Employers currently offering the streamlined plans will receive <u>a letter</u> regarding these changes 90 days prior to their renewal. We are planning for the first set of letters to be sent in late November 2019 for March 2020 effective dates.
